- g. Logo in high resolution.

## CODE OF CONDUCT

- a. All persons authorized by the member company can participate in the activities of the Guatemalan-American Chamber of Commerce.
- b. All membership applications will be evaluated by the Membership Committee as established in the charter of AmCham, article XXXVII.
- c. The fees and contributions determined by the Board of Directors must be paid in advance (AmCham charter, Article XI, letter "c").

- e. If you wish to withdraw from membership, you must send a formal letter addressed to the Guatemalan-American Chamber of Commerce stating the reason, signed by the General Manager or Legal Representative of the company.
